Florida Department of Law Enforcement Transportation and Protective Services Report July 1, 2022 through June 30, 2023

Background. The Florida Department of Law Enforcement (FDLE) is directed by Section 943.68, F.S., to provide an annual report detailing all transportation and protection services costs for:

- The Governor, the Governor's immediate family, the Governor's Office, Mansion and grounds [Section 943.68(1), F.S.];
- Visiting governors and families upon request by the Governor [Section 943.68(5), F.S.]; and
- Other persons visiting the state for whom such services are requested by the Governor, the Lieutenant Governor, a member of the Cabinet, the Speaker of the House of Representatives, the President of the Senate, or the Chief Justice of the Supreme Court and for whom the failure to provide security or transportation could result in a clear and present danger to the personal safety of such persons or could result in public embarrassment to the state [Section 943.68(6), F.S.].

Pursuant to Section 943.68(7), F.S., the Department is also directed to coordinate all protective services with the United States Department of State and the United States Secret Service when requested to do so by such agencies or by the Governor or member of the Cabinet. While not specifically required by statute, these costs are also captured in this report.

Tables. This report is separated into two tables. Table 1 includes those costs incurred under Section 943.68(1), F.S., for the period July 1, 2022 through June 30, 2023. The total cost identified in this table was \$9,418,861.95. Table 2 includes those costs incurred under Sections 943.68(5-7), F.S. For the same time period, 97 protective details were performed and the total cost identified in this table was \$457,242.39. The total amount for protective costs for this period was \$9,876,104.34.

Table 1 includes the following information for the Governor, the Governor's Office, Governor's Family, Mansion and grounds:

- **Activity** – Type of protection service, including expenditures for conducting security advances and protection details. Advances require securing venue prior to protectee's arrival.
- **Salary** – Salary costs incurred to provide protective services.
- **Transportation / Expenditures** – Travel and transportation costs incurred to provide protective services. Includes per diem costs and other authorized expenditures by the Department.

Table 2 includes the following information for visiting dignitaries (protectee):

- **Date** – Date(s) the protective service was performed.
- **Service Provided** – Individual for whom protective services were provided.
- **Salary** – Salary costs incurred to provide protective services.
- **Transportation / Expenditures** – Travel and transportation costs incurred to provide protective services. Includes per diem costs and other authorized expenditures by the Department.
- **Regional Operations Center(s)** – The primary FDLE Regional Operations Center assigned to provide transportation and protective services for an authorized protectee.
- **Nature of Business** – Primary nature of the protectee's business while visiting the state.
